Listeners Community Radio of Utah, Inc. ("LCRU"), licensee of noncommercial educational FM station KRCL (FM-NCE), Salt Lake City, Utah, is a non-stock, non-profit organization. LCRU is filing this application to obtain Commission consent to new members of its Board of Directors.

The selection of LCRU's new Board of Directors took place pursuant to its Articles of Incorporation and By-Laws. The resulting transfer of control occurred gradually, over time, through routine changes in board membership.

This application is intended to bring the station into compliance with the requirement to obtain FCC approval of the board after 50% of the members of the board of directors have changed. The members of the Board last submitted in a transfer of control application with the Commission (FCC File No. BTCED-20090522AFB), granted June 8, 2009, through the current year, following the annual business meeting each year, are set forth in the chart below.

No consideration or thing of value is being given in exchange for the interests being transferred. The transfer does not involve any change in the non-profit status or objectives of the licensee. All Board Members are U.S. citizens. Each Board Member has one vote. None has any interest in any mass media other than in the licensee.
